### Safety Rules, Policy & Procedures

- **TREAT ALL GUNS AS IF THEY ARE ALWAYS LOADED.**
- **NEVER LET YOUR MUZZLE COVER ANYTHING YOU ARE NOT WILLING TO DESTROY**
- **KEEP YOUR FINGER OUT OF THE TRIGGER GUARD UNLESS YOUR SIGHTS ARE ON THE TARGET**
- **ALWAYS BE CERTAIN OF YOUR TARGET**

1. Only handle your loaded firearm on the firing line. When arriving at the range, all guns must be stored in a case or range bag and must be unloaded. The exception to this rule is your concealed carry piece which may be loaded. It may only be un-holstered or holstered for use while you are within your shooting station.
2. When loading or unloading your firearm, keep the muzzle pointed downrange (toward the target area). The muzzle should never sweep stations to your right or left, or any part of your body.
3. Do not dangle your pistol at your side. The firearm should be at the ready, on target, or grounded on your shooting station.
4. Do not turn around with a firearm in your hand. If needed, turn your head to speak to a range safety officer, instructor, etc. Keep your firearm pointed downrange and finger off the trigger.
5. Shoot only at authorized targets in authorized frames and carriers within your shooting station.
6. Immediately obey all commands of the designated range safety officer. The range safety officer has complete authority over all shooters in the live fire area. Failure to obey a range safety officer is grounds for immediate removal without refund and/or revocation of membership.
7. During a cease fire, all shooters must step back behind the yellow line. Handling firearms or approaching the shooting stations during a cease fire is absolutely forbidden.
8. Proper safety equipment for eyes and ears is required at all times for shooters in live-fire area. Hearing protection devices may be either the passive or electronic type. Safety glasses or corrective lens are both acceptable. No Open Toe Shoes or Low Cut tops.
9. No drawing from the holster. Exceptions to this rule will apply during special events and formal training sessions.
10. Rapid fire is allowed in a controlled and safe manner. It will be the discretion of the range safety officer to restrict rapid fire to 1 round per second if the shooter is not able to control the firearm safely.
11. There shall be no use of intoxicants of any kind on the range. We reserve the right to refuse service to anyone suspected of being under the influence of intoxicants.
12. Individuals 17 years and younger may fire on the range only when under the direct supervision of their guardian. Individuals 17 years and younger are not allowed on the range premises unless they are under the direct supervision of an adult, who shall be responsible for them and keep them behind the firing line and out of danger zones.
13. Anyone causing damage to range equipment or facilities shall be personally and monetarily liable for such damage.
14. The range shall not be responsible for personal property or equipment left on the premises.
15. Permitted Calibers: Only those firearms for which the range has been designed will be allowed:
  - a. Pistol: Max .50 caliber on the 25-yard pistol range
  - b. Rifle: Max .338 Lapua on the 50-yard rifle range
  - c. Shotgun: Slugs only on the 50-yard rifle range
  - d. Class III: Silencers and suppressors can use either range
16. Prohibited Firearms: Muzzle loaders and black powder.
17. The use of incendiary devices, armor piercing, green tip, and/or tracer ammunition is strictly prohibited. Lasers are prohibited on the rifle range.
18. Each shooter is required to clean up the area after completing their range session. You may collect your own brass, if accessible, within reach of your immediate station.
19. Pregnant women are not permitted in the live fire area.
20. No smoking, eating, or drinking permitted in the ready room or live-fire area. Use lockers in Prep Room to store your items.
21. Maximum capacity in live-fire area is 20 shooters on the pistol range, and 12 shooters on the rifle range, up to two people per station.

AGREEMENT, RELEASE, INDEMNIFICATION, COVENANT NOT TO SUE, AND WAIVER OF LIABILITY  
(READ CAREFULLY BEFORE SIGNING)

The undersigned agrees to abide by all of the range rules and safety rules of Shady Oaks Gun Range and Archery Range, and the undersigned represents that he or she understands all of these rules, and was given the opportunity to ask for clarification of any of the rules before signing this Agreement. The undersigned understands that Shady Oaks Gun Range reserves the right to eject from the premises any individual who violates any of the rules of Shady Oaks Gun Range or otherwise acts in any unsafe manner as determined by Shady Oaks Gun Range. The undersigned agrees to peaceably leave the premises of Shady Oaks Gun Range if so ejected, after paying for all services and merchandise. The undersigned further swears, warrants and represents, under penalty of perjury, that all information provided above is true and correct. The undersigned understands that any possession of a firearm by a convicted felon is a serious crime prohibited by Federal law and Texas law, and that Shady Oaks Gun Range will cooperate fully with any and all Federal and State authorities with the investigation and prosecution of such crimes.

In consideration of the acceptance of my participation, directly or as a spectator or observer, in any activity, class, competition, firing range rental, firearm rental, archery range usage, or other use of the facilities of Shady Oaks Gun Range (hereinafter, collectively, "Activity"), THE UNDERSIGNED AGREES TO ASSUME THE RISKS incidental to such participation and, on my own behalf and on behalf of my heirs, executors and administrators, I RELEASE, INDEMNIFY, HOLD HARMLESS, COVENANT NOT TO SUE, AND FOREVER DISCHARGE the Released Parties defined below, of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my participation in any such Activity. The Released Parties are Shady Oaks Gun Range, its parent, related, affiliated and subsidiary companies, and the officers, directors, employees, agents, representatives, insurers, successors, heirs and assigns of each. The undersigned expressly understands that the Release, Indemnification, Covenant Not to Sue, and Waiver of Liability provisions of this Agreement clearly and unequivocally include and apply to any claims based on the negligence (whether active or passive), ownership of any dangerous instrumentality, action or inaction of or by any of the above Released Parties, including, but not limited to, claims for bodily injury, death and property damage or loss suffered by me as a result of such participation in any Activity. Additionally, the undersigned further agrees to indemnify and hold the Released Parties harmless from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my participation in any activity which results in the personal injury or death of anyone whatsoever, or loss or damage to the property of anyone whatsoever (including the loss of use thereof). Further, I, the undersigned, agree, on my own behalf and on behalf of my heirs, executors and administrators, to pay Shady Oaks Gun Range, Inc. for any damage to the Released Parties arising in any way out of any Activity and caused by me in any way, negligently or intentionally, including, but not limited to, property damages, personal injury damages, cleaning costs, loss of use damages, business interruption damages, damage to goodwill or reputation, medical costs, counseling costs, and attorney's fees.

In entering into this Agreement, I hereby grant the Released Parties a limited power of attorney and authorization to obtain, at my cost, any and all emergency medical treatment which may be needed by myself as a result of participation in any Activity. For the purposes of this Agreement, emergency medical treatment means medical care or treatment necessitated by a sudden, unexpected situation or occurrence resulting in a serious medical condition demanding immediate medical attention. However, I release, indemnify, hold harmless, covenant not to sue, and forever discharge the Released Parties of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with the exercise or the failure to exercise such limited power of attorney and authorization, whether negligent or otherwise.

I expressly agree that this Agreement is intended to be as broad and inclusive as permitted by law, and that if any provision of this Agreement is held illegal, invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby, and such invalid part, term or provision shall not be deemed part of this Agreement. I further agree that any ambiguities in this Agreement shall not be construed in favor or against any party by virtue of that party having drafted the Agreement. No remedy conferred by any of the specific provisions of this Agreement is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder shall not constitute any waiver of the right to pursue other available remedies.

I certify that I am eighteen (18) years of age or older and that I am entering into this Agreement on my own behalf. I expressly understand that the aforementioned Activity includes the discharge of firearms, firing of live ammunition, and/or usage of the archery range. I further certify that I have completely read the foregoing and I expressly agree to all of the provisions of this Agreement.
